**PRAYER:** Writ Petition filed under Article 226 of the Constitution of India seeking a Writ of Mandamus, directing the respondents 1 to 7 to interrogate about the suppression of Tamil Nadu Government Gazette No.25 part 6, dated 02.06.1980 under which the Thevar Educational Society having Registration number 43/1969 was declared as defunct and consequent usurpation of both movable and immovable properties of the said society and UGC and Government grants by the new Thevar Educational Society having Registration number 78/1971, the 8<sup>th</sup> respondent herein and to take appropriate legal action against the present management of the 8<sup>th</sup> and 9<sup>th</sup> respondents and to restore Thevar Educational Society having Registration number 43/1969 within a stipulated time limit.

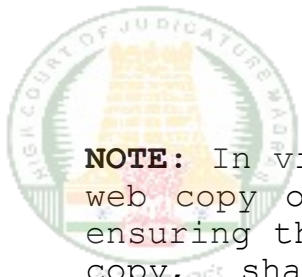
