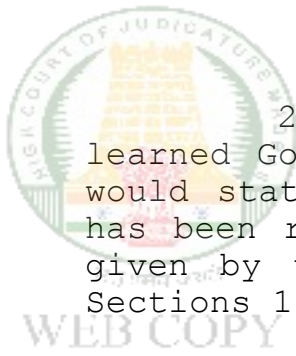

2.Today when the Writ petition is taken up for hearing, the learned Government Advocate appearing for the respondent Nos.1 & 2 would state that First Information Report in Crime No.129 of 2020 has been registered against the petitioner, based on the complaint given by the third respondent, for the offences punishable under Sections 143, 468, 471 and 420 IPC.

3. In view of the subsequent developments, the Writ petition is dismissed as infructuous. No costs. The petitioner is at liberty to approach the appropriate forum for his remedy.
