PRAYER :- For Anticipatory Bail in Crime No.1326 of 2020 on the file of the Respondent Police.

ORDER : The Court made the following order :-

The petitioner, who is arrayed as accused (Rank not known) apprehending arrest at the hands of the respondent police for the offence punishable under Section 379 I.P.C., and Section 21(1), 21 (2) of Mines and Minerals (Development & Regulation) Act, 1957, in Crime No.1326 of 2020, seeks anticipatory bail.
