PRAYER :-

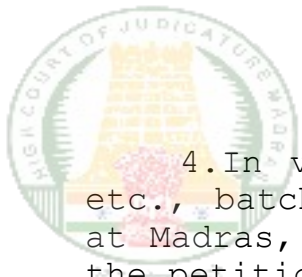
For Anticipatory Bail in Crime No. 1616 of 2020 on the file of the respondent police

ORDER : The Court made the following order :-

The petitioner, who is arrayed as A1 apprehending arrest at the hands of the respondent police for the offence punishable under Section 379 I.P.C., in Crime No.1616 of 2020, seeks anticipatory bail.
