PETITION FOR ANTICIPATORY BAIL Under Section 438 of Cr.P.C

PRAYER :-

For Anticipatory Bail in Crime No.459 of 2020 on the file of the Respondent Police.

ORDER : The Court made the following order :-

The petitioner/A-1, apprehending arrest at the hands of the respondent police for the offence punishable under Section 379 of IPC. r/w Section 21(4) of Tamil Nadu Mines and Minerals (Development & Regulation) Act, 1957, in Crime No.459 of 2020, seek anticipatory bail.

2.The case of the prosecution is that the petitioner along with other accused persons said to have illegally transported Two Unit of river sand using two Tractors. Hence, a case has been registered.

3.Heard the learned counsel appearing for the petitioners and the learned Government Advocate (Criminal Side) appearing for the respondent Police.



4. In view of the order passed in Crl.O.P.No.13334 of 2020 etc., batch, dated 03.09.2020 by the Principal Bench of this Court at Madras, this Court is not inclined to grant anticipatory bail to the petitioners.

5. Accordingly, this criminal original petition stands dismissed.
