PETITION FOR ANTICIPATORY BAIL Under Sec.438 of Cr.P.C

PRAYER :- For Anticipatory Bail in Crime No.23 of 2020 on the file of the Respondent Police

ORDER : The Court made the following order :-

The petitioner/A-2 apprehending arrest at the hands of the respondent police for the offence punishable under Section 379 of I.P.C. r/w Section 21(1), 21(2) of Tamil Nadu Mines and Minerals (Development & Regulation) Act, 1957, in Crime No.23 of 2020, seeks anticipatory bail.

2.The case of the prosecution is that the petitioner said to have illegally transported Three Unit of river sand using Lorry bearing Regn. no.TN-52-B-6366. Hence, a case has been registered.

3.Heard the learned counsel appearing for the petitioners and the learned Government Advocate (Crl. Side) appearing for the respondent Police.

4. In view of the order passed in Crl.O.P.No.13334 of 2020 etc., batch, dated 03.09.2020 by the Principal Bench of this Court at Madras, this Court is not inclined to grant anticipatory bail to the petitioner.



5. Accordingly, this criminal original petition stands dismissed.
