PETITION FOR BAIL Under Sec.439 of Cr.P.C.

PRAYER :-

For Bail in Crime No. 83 of 2014 on the file of the Respondent Police

ORDER : The Court made the following order :-

The petitioner/accused, who was arrested and remanded to judicial custody on 10.09.2019 for the offences punishable under Sections 294(b) of IPC and Section 3(1) of TNPPDL Act on the file of the respondent police seeks bail.

2. Earlier the petitioner was granted bail and subsequently the petitioner failed to appear before the trial court hence Non Bailable Warrant was issued on 18.03.2019. Thereafter the petitioner was arrested and remanded to judicial custody on 10.09.2019, hence seeking bail the present application is filed.

3.The learned Government Advocate(Crl.Side)would submit that petitioner herein was secured after much difficulty and if he is released on bail, he will indulge in similar types of offences again. He would also submit that 18 previous cases are pending against him.



4. Taking into consideration the facts and circumstances of the case and also taking into consideration the submission made by the learned Government Advocate(Crl.Side), this Court is not inclined to grant bail to the petitioner.

5. Hence the petition stands dismissed. However the Sessions Court is directed to complete the trial in S.C.No.126 of 2018 as expeditiously as possible preferably within a period of six months from the date of receipt of a copy of this order.
