5.Recording the submission made by the learned Additional Public Prosecutor, this Criminal Original Petition is closed.

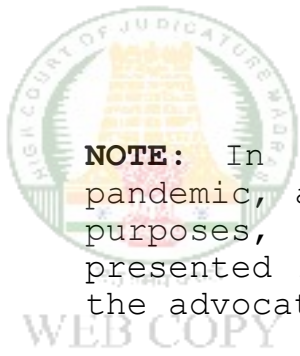
