PRAYER: Contempt Petition filed under Section 11 of the Contempt of Court Act, to punish the respondent for committing contempt by wilful disobedience of the order passed in W.P(MD)No.6484 of 2020 dated 09.07.2020.

Prayer: Writ Petition filed under Article 226 of Constitution of India, praying to issue a writ of Mandamus, directing the respondents to settle the interest at the rate of 18% p.a. on the belated payment of arrears of salary of Rs.6,15,721/- due from 30.09.1986 and arrears of surrender leave salary of Rs.44,382/- to till the date of settlement in January 2020 and also to settle the interest on the belated payment of arrears of pension of Rs.7,18,414/-, arrears of commutation of Rs.88,955/- and arrears of Gratuity of Rs.1,07,865/- from the date of retirement on 31.3.2010 till the date of settlement in February 2020 in the light of the judgment of the Hon'ble Supreme Court reported in 2000 (3) LLN 1 dated 31.1.2000.
