PETITION FOR ANTICIPATORY BAIL Under Sec.438 of Cr.P.C

PRAYER :-

For an Anticipatory Bail in Crime No.18 of 2020 on the file of the respondent police.

ORDER : The Court made the following order :-

The petitioners, who arrayed as accused Nos.2 and 5 apprehending arrest at the hands of the respondent police for the offence punishable under sections 406, 408, 409, 420, 477A, 381, 120B and 34 IPC in Crime No.18 of 2020 on the file of the respondent police, seeks anticipatory bail.

2.The amount of misappropriated in TASMACH by these accused persons is a sum of Rs.1,74,95,810/- . The case is under investigation. In view of the fact that huge amount has been allegedly misappropriated from the TASMACH, which is the Government organization, granting of anticipatory bail during the course of investigation is not preferable. The respondent police is bound to



intensify the investigation and cull out the truth regarding the large scale misappropriation of public money. Thus, the petition devoid of merits and stands dismissed.
