Prayer in WP(MD). 6478/ 2020 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ or direction in the nature of a Writ of Mandamus directing the respondents to regularize the petitioner service as Full Time Sweeper on the date of completion of ten years of part time service from 5.12.1990 and to pay time scale of pay and other benefits payable with effect from 5.12.2020 by counting the 50 percent of part time service for the purpose of pension in the light of the order passed in WA(MD).No.93/2018 dated 27.3.2018 as confirmed by the apex court by dismissal of SLP.No.23960
