PRAYER: Contempt Petition is filed under Section 11 of the Contempt of Court Act 1971, to punish the Contemnor / Respondent No.1 for the wilful disobedience of the order dated 09.06.2020 passed in W.P(MD)No.6514 of 2020.

Prayer in WP(MD). 6514/ 2020 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus directing the respondents to regularize the petitioner service as Full-Time Sweeper on the date of completion of ten years of part time service from 03.07.1989 and to pay time scale of pay and other benefits payable with effect from 03.07.1999 by counting the 50 percentage of part time service for the purpose of pension in the light of the order passed in W.A(MD).No. 93/2018 dated 27.03.2018 as confirmed by the apex court by dismissal of S.L.P.No. 23960 of 2018.
