PRAYER: Petition filed under Article 226 of the Constitution of India to issue a Writ of Mandamus, directing the respondents to release the vehicle bearing registration No.TN-74 AP 9775 to the petitioner forthwith based on the representation dated 03.11.2020.

O R D E R

This writ petition has been filed for a Mandamus to direct the respondents to release the vehicle bearing registration No.TN-74 AP 9775 to the petitioner forthwith based on the representation dated 03.11.2020.

2. Heard Mr.M.Murugesan, learned counsel appearing for the petitioner and Mr.M.Rajarajan, learned Additional Government Pleader appearing for the respondents.

3. By consent of both parties, the Writ Petition is taken up for final disposal at the admission stage itself.

4. It is the case of the petitioner that he is the owner of the aforementioned vehicle. According to the petitioner, on 23.10.2020, the petitioner's driver namely Venkatesan Muthukumaran took the vehicle of the petitioner. The respondent police with few other



officials, intercepted the vehicle belonging to the petitioner driven by one Venkatesan Muthukumaran and found that without proper permit, he was illegally transiting the Government ration shop rice containing 390 kgs worth Rs.1,695/- and registered a case in Crime No.162 of 2020 for the alleged offence under Section 6(4) of TNSC (RDSCS) Order, 1982 and 7(1)(a)(ii) of Essential Commodities Act, 1955. The second respondent has handed over the vehicle to the first respondent.

5. It is the contention of the petitioner that he is never involved in any illegal transportation of PDS Rice as alleged by the Police and he has not committed any prior criminal offence. According to the petitioner, the seized vehicle is now being kept in the open place and due to exposure of sun and rain and the vagaries of nature, the vehicle will lose its value and may, ultimately become a wreck and worthless. In such circumstances, this Writ Petition has been filed seeking for release of the said vehicle.

6. The petitioner has also given a representation on 03.11.2020 to the respondents seeking for release of the said seized vehicle. According to the petitioner, the said representation has not been considered by the respondents till date. As rightly contended by the petitioner, if the vehicle, which was seized by the second respondent, is kept in the open place, it will not be useful to anyone in the near future and if it is continued to remain in the open, it has to face the vagaries of nature and ultimately will become a wreck and worthless. However, whether the petitioner has committed the alleged offence or not can be adjudicated only after trial before the Criminal Court. Till such time, the vehicle cannot be kept idle. Therefore, this Court is inclined to grant an order as sought for by the petitioner in this Writ Petition, subject to the fulfillment of the following conditions by the petitioner.

(i) Since it is the case involving seizure of PDS Rice, the petitioner cannot give security by way of bond, in stead will have to give cash security. Accordingly, the petitioner shall deposit a sum of **Rs.25,000/- (Twenty five thousand only)** with the first respondent within a period of two weeks from the date of receipt of a copy of this order;

(ii) the petitioner shall give an unconditional undertaking to the first respondent that he shall not alienate or encumber the vehicle in question without permission of the Jurisdictional Magistrate till the completion of the confiscation proceedings;

(iii) the petitioner shall not change the colour and scheme of the vehicle;



(iv) the petitioner shall not use the vehicle for any illegal activities;

(v) before releasing the vehicle, the police authority shall take photographs of the vehicle at the cost of the petitioner;

(vi) The petitioner shall produce all xerox copies of the documents pertaining to the ownership of the seized vehicle to the first respondent; and

(vii) As and when the respondents call for the vehicle for enquiry, the petitioner has to produce the vehicle in question and he shall cooperate with the enquiry to be conducted by the respondents.

7. Upon completion of the above mentioned formalities, the first respondent shall release the vehicle bearing registration No.TN-74 AP 9775 to the petitioner forthwith without any delay. If this undertaking given by the petitioner is breached, the petitioner will not be entitled to interim release of the vehicle in future. As far as confiscation proceedings initiated against the seized vehicle is concerned, the same can go on without any interference.

8.The Writ Petition is disposed of accordingly. There shall be no order as to costs.
