The petitioner is shown as sole accused in Crime No.25 of 2020 registered on the file of the Inspector of Police, All Women Police Station, Srirangam, Trichy City, Trichy District for the offence under Sections 294(b), 354 (A), 354 (d), 355 I.P.C r/w Sections 3(1)(r), 3(1)(s), 3(1)(w)(2), 3(2)(va) of Scheduled Caste and Scheduled Tribes (Prevention of Atrocities) Amendment Act, 2015.
