PRAYER: Petition filed under Article 226 of the Constitution of India to issue a Writ of Mandamus, to direct the respondents to release the petitioner's Ashok Leyland (Dost)-bearing Registration No.KL 04 AC 8785 seized by the second respondent Police in connection with Crime No.75 of 2020, dated 13.06.2020 on the basis of the petitioner's representation dated 14.10.2020.

ORDER

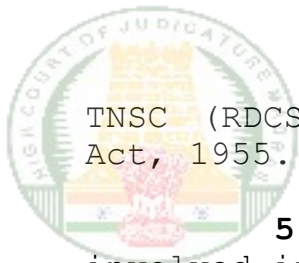
(This Petition was heard through the Video Conferencing)

This writ petition has been filed for a Mandamus seeking for a direction to the respondents to release the petitioner's Ashok Leyland (Dost)-bearing Registration No.KL 04 AC 8785 seized by the second respondent Police in connection with Crime No.75 of 2020, dated 13.06.2020 on the basis of the petitioner's representation dated 14.10.2020.

2. Mr.A.Muthu Karuppan, learned Additional Government Pleader accepts notice on behalf of the respondents. By consent of both parties, the Writ Petition is taken up for final disposal at the admission stage itself.

3. Heard Mr.T.Selvakumaran, learned counsel appearing for the petitioner and Mr.A.Muthu Karuppan, learned Additional Government Pleader appearing for the respondents.

4. It is the case of the petitioner that he is the owner of the aforementioned vehicle. According to the petitioner, the second respondent seized his vehicle on 13.06.2020 alleging that the vehicle was used to transport PDS rice and a case was registered in Crime No.75 of 2020 for the alleged offence under Section 6(4) of



TNSC (RDCS) Order 1982 r/w. 7(1)(a)(ii) of Essential Commodities Act, 1955.

5. It is the contention of the petitioner that he is never involved in any illegal transportation of PDS Rice as alleged by the Police and he has not committed any prior criminal offence. According to the petitioner, the seized vehicle is now being kept in the open place and due to exposure of sun and rain and the vagaries of nature, the vehicle will lose its value and may, ultimately become a wreck and worthless. In such circumstances, this Writ Petition has been filed seeking for release of the said vehicle.

6. The petitioner has also given a representation on 14.10.2020 to the second respondent seeking for release of the said seized vehicle. According to the petitioner, the said representation has not been considered by the second respondent till date. As rightly contended by the petitioner, if the vehicle, which was seized by the second respondent, is kept in the open place, it will not be useful to anyone in the near future and if it is continued to remain in the open place, it has to face the vagaries of nature and ultimately will become a wreck and worthless. However, whether the petitioner has committed the alleged offence or not can be adjudicated only after trial before the Criminal Court. Till such time, the vehicle cannot be kept idle. Therefore, this Court is inclined to grant an order as sought for by the petitioner in this Writ Petition, subject to the fulfillment of the following conditions by the petitioner.

"(i) Since it is the case involving seizure of PDS Rice, the petitioner cannot give security by way of bond, instead will have to give cash security. Accordingly, the petitioner shall deposit a sum of Rs.25,000/- (Rupees Twenty Five thousand only) with the second respondent within a period of two weeks from the date of receipt of a copy of this order.

(ii) the petitioner shall give an unconditional undertaking to the second respondent that he shall not alienate or encumber the vehicle in question without permission of the Jurisdictional Magistrate till the completion of the confiscation proceedings

(iii) the petitioner shall not change the colour and scheme of the vehicle.

(iv) the petitioner shall not use the vehicle for any illegal activities.

(v) before releasing the vehicle, the police authority shall take photographs of the vehicle at the cost of the petitioner.



(vi)The petitioner shall produce all xerox copies of the documents pertaining to the ownership of the seized vehicle to the second respondent.

(vii)As and when the respondents call for the vehicle for enquiry, the petitioner has to produce the vehicle in question and he shall cooperate with the enquiry to be conducted by the respondents."

7. Upon completion of the above mentioned formalities, the respondents shall release the Ashok Leyland (Dost)-bearing Registration No.KL 04 AC 8785 to the petitioner forthwith and without any delay. If this undertaking given by the petitioner is breached, the petitioner will not be entitled to interim release of the vehicle in future. However, if there is any confiscation proceedings initiated against the seized vehicle, the same can go on without any interference.

8.The Writ Petition is disposed of accordingly. There shall be no order as to costs.
