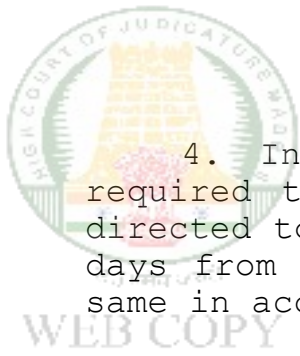
**O R D E R**
