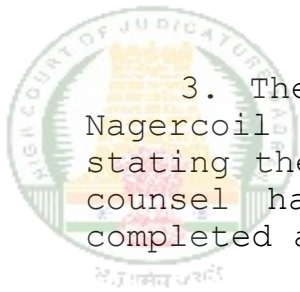
Prayer :-

ORDER:- This Civil Revision Petition coming on for orders on this day and upon perusing the earlier order of this Court and Letter in D.No.402 /2021 dated 30.06.2021 received from The Judge, Family Court, Kanniyakumar District at Nagercoil, seeking to grant further six months time to dispose the case and this Court made the following order:
