Prayer in WP(MD).No.16512 of 2020 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus directing the respondents 1 to 5 herein to complete the remaining demolition of dobikana (washing) building belonging to government situated nearby community hall in the 5th respondent village panchayat as per the proceedings of 1st respondent herein in Na.Ka.No.28/2020/T4 dt 06.03.2020 and work order issued by the 3rd respondent in Na.Ka.No.745/2020/A3 dt 19.06.2020. within a stipulated time to be fixed by this Hon'ble Court and consequently initiate penal action against the 6th respondent for wrongful restraint and interference in the exercise of function of the respondents 1 to 5 herein under the law.
