**Prayer in CRL OP(MD) . 5497 OF 2020 :**

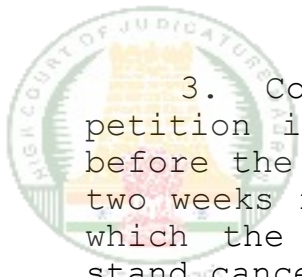
This Petition filed under Section 482 of CPC to direct the
