Prayer in WP(MD) NO.19148/2019:

Writ petition filed under Article 226 of the Constitution of India, praying this court calling for the records pertaining the impugned patta grant order in Na.Ka.No.3655/2018/E2 dated 20/02/2019 on the file of the 3rd respondent, quash the same as illegal and direct the 1 and 2nd respondents to verify the eligibility of the beneficiaries by forming a special committee and thereafter re-allocate the free house site pattas to the deserving eligible applicants.

ORDER:- This Petition coming upon for orders on this day and upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of Mr.K.Navaneetharaja, Advocate for the Petitioner and of Mrs. J.
