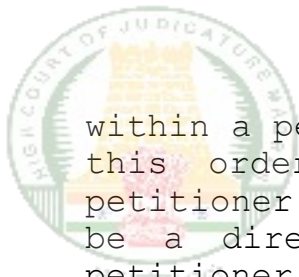
ORDER

The petitioner is shown as accused No.1 in Crime No.641 of 2020 registered on the file of the Inspector of Police, Kalakkadu Police Station, Tirunelveli District, for the offence punishable under Sections 294(b), 323 of I.P.C 3(1)(r), 3(1)(s) and 3(2)(va) of Schedule Caste and Schedule Tribes (Prevention of Atrocities) Amendment Act, 2015.

2.The learned counsel appearing for the petitioner reiterated the contentions set out in the original petition.

There will be a direction to the respondents 1 and 2 not to arrest the petitioner till the expiry of the period of eight weeks.
