To set aside and modify one of the condition namely deposit of cash security of Rs.1,00,000/-(Rupees One Lakh) as imposed by the learned Principal Sessions Judge, Madurai in his order granting bail to the petitioner/second accused dated 11.11.2020 made in Crl.M.P.No.4909 of 2020 on the file of the Principal Sessions Judge, Madurai.
