complainant has represented before this Court that the matter has been settled amicably between the parties. The learned Additional Public Prosecutor, who was present in the Court, had also verified their identity and would state that he has no objection for the above compromise.

In the result, by recording the compromise, the Criminal Original Petition is allowed and the charge sheet in C.C.No.4 of 2018 on the file of the Special Court for Land Grabbing Cases, Tirunelveli, Tirunelveli District, is quashed. The joint compromise memo shall form part and parcel of this order.
