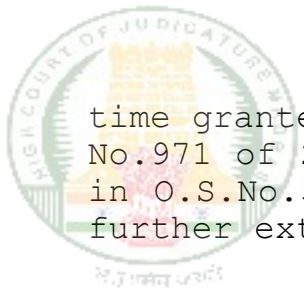
PRAYER:-
