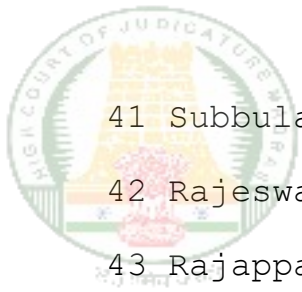

At that time all the Subordinate Courts in Thanjavur District were not permitted to be opened for physical hearing and also submit that the copy was received only on 29.06.2021.
