3.It is seen that the petitioner is paying a sum of Rs.4000/- regularly as directed by this Court but due to covid -19 pandemic the petitioner is unable to furnish sureties. Considering the above, this petition is ordered and the time for surrender by the petitioner before the concerned Court and executing the sureties is extended by two weeks from the date of receipt of a copy of this order, failing which the anticipatory bail already granted by this Court shall stand cancelled.



4. Accordingly, this Criminal Miscellaneous Petition is allowed.
