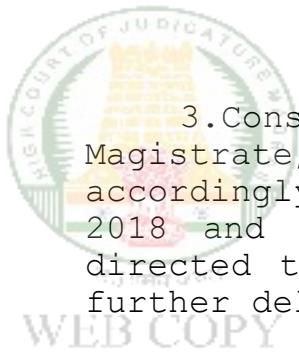
PRAYER:-
