ORDER

This Writ Petition is filed to direct the respondents to consider the petitioner's representation dated 24.10.2020 and to direct the respondents 2 and 3 to provide a job to the petitioner on compassionate ground.

2.By consent, the writ petition is taken up for final disposal at the admission stage itself.

3.It is the grievance of the petitioner that his father died on 17.10.1994, while he was in service. Though the 4th respondent, by proceedings dated 24.08.2018, had recommended the 3rd respondent to provide a suitable job to the petitioner on compassionate ground, so far no action has been taken, for which, the petitioner has made representations dated 13.10.2020 and 24.10.2020 to the respondents and the same is pending till today. Hence, the present writ petition.



4.In reply, Mr.A.Thiagarajan, learned Government Advocate appearing for the respondents would fairly submit that the petitioner's representations dated 13.10.2020 and 24.10.2020 would be considered on merits and in accordance with law, within a time frame to be fixed by this Court.
