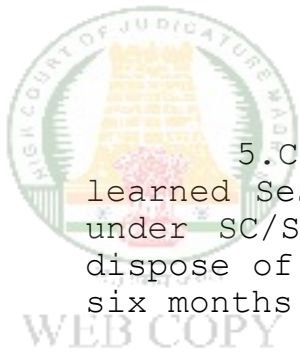
O R D E R

5.Considering the facts and circumstances of the case, the learned Sessions Judge, Special Court for Trial of Cases registered under SC/ST (POA) Act, 1989, Ramanathapuram is hereby directed to dispose of the case in Special S.C.No.74 of 2019, within a period of six months from the date of receipt of a copy of this order.
