ORDER

4.In reply, Mr.N.Shanmugaselvam, learned Additional Government Pleader appearing for the respondents would fairly submit that no counselling has been held to date for transfer and during the course of next counselling, the petitioner's request will be



5.The learned counsel appearing for the petitioner has also agreed with the submission made by the learned Additional Government Pleader.

6.In view of the submissions made by the learned counsel on either side, this Court is inclined to pass the following directions:-

the respondents are directed to consider the petitioner's request for transfer as and when the next counselling for transfer is held, as submitted by the learned Additional Government Pleader appearing for the respondents;

7.With the above direction, the Writ Petition stands disposed of. No costs. Consequently, connected miscellaneous petition is closed.
