PETITION FOR ANTICIPATORY BAIL Under Sec.438 of Cr.P.C

PRAYER :- For Anticipatory Bail in Crime No. 6/2020 on the file of the respondent police

ORDER : The Court made the following order :-

The petitioner apprehending arrest at the hands of the respondent police for the offences punishable under sections 419, 420. 467, 468, 471 and 120(b) of I.P.C., in Crime No.6 of 2020 on the file of the respondent police, seeks anticipatory bail.

2.It is seen that this is the second application seeking anticipatory bail. The earlier anticipatory bail application in Crl.OP(MD)No.10705 of 2020 was dismissed on merit by this Court on 08.10.2020. Further, the rank of the accused is not important factor since he is having specific overt act on the case of impersonation.

3.Taking into consideration of the fact that there is no change of circumstances after dismissal of the earlier bail application in Crl.OP(MD)No.10705 of 2020, this Court is not inclined to grant anticipatory bail to the petitioner.



4. Accordingly, this Criminal Original Petition stands dismissed.
