PETITION FOR ANTICIPATORY BAIL Under Sec.438 of Cr.P.C

PRAYER :-

For Anticipatory Bail in Crime No.16 of 2020 on the file of the Respondent Police.

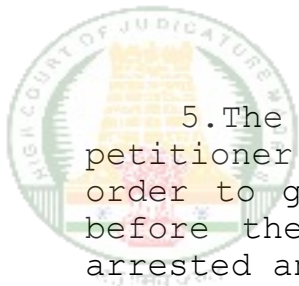
ORDER : The Court made the following order :-

The petitioner/A2, who apprehend arrest at the hands of the respondent police for the offences punishable under Sections 120(B), 406, 420, 465, 466, 467, 468, 471 and 472 of IPC, seeks anticipatory bail.

2.Heard both sides.

3.The case of the prosecution is that the Sub-Registrar of Komankudikkottai lodged a complaint before the respondent police, in which, he has stated that the petitioner and other accused created forged written cheque slip of the Sub-Registrar Office along with the forged seal and signature and the same was produced before the Court of law.

4.The learned counsel for the petitioner would submit that the petitioner is innocent and she has been falsely implicated in this case.



5.The learned Government Advocate(Crl.Side) submitted that the petitioner along with other accused created forged documents in order to grab the property and submitted the said forged documents before the Court of law. She would further submit that A-1 is arrested and the investigations are going on.

6.Taking note of the above facts and circumstances of the case, this Court is inclined to grant anticipatory bail to the petitioner with certain conditions.

7.Accordingly, the petitioner is ordered to be released on bail in the event of arrest or her appearance, within a period of fifteen days from the date of receipt of a copy of this order, before the learned Judicial Magistrate No.IV, Thoothukudi, on condition that the petitioner shall execute a bond for a sum of Rs.10,000/- (Rupees Ten thousand only) with two sureties each for a like sum to the satisfaction of the respondent Police or to the Police Officer, who intends to arrest or to the satisfaction of the learned Magistrate concerned and on further condition that:

(a)the petitioner and the sureties shall affix their photographs and left thumb impression in the surety bond and the Magistrate may obtain a copy of their Aadhar card or Bank pass Book to ensure their identity;

(b)the petitioner shall report before the respondent police every day twice morning at 10.00 a.m. and evening at 06.00 p.m., for a period of four weeks and thereafter, the petitioner shall appear before the respondent police daily morning at 10.00 a.m., for a period of two weeks and therefrom as and when required for interrogation.

(c)the petitioner shall not tamper with evidence or witness either during investigation or trial;

(d)the petitioner shall not abscond either during investigation or trial;

(e)on breach of any of the aforesaid conditions, the learned Magistrate/ Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in ***P.K.Shaji Vs. State of Kerala [(2005) AIR SCW 5560]***; and;

(f)if the accused thereafter absconds, a fresh FIR can be registered under Section 229-A IPC.
