PRAYER :-

For an Anticipatory Bail in Crime No.980 of 2020 on the file of the respondent police.

The petitioners, who are arrayed as accused, apprehending arrest at the hands of the respondent police for the offence punishable under Section 379 I.P.C. r/w Section 21(1) of Tamil Nadu Mines and Minerals (Development and Regulation), Act, 1957, in Crime No.980 of 2020, seeks anticipatory bail.
