Since there was a possibility for communal clash, a case was registered in Crime No. 8 of 2019 under Section 107 Cr.P.C,



in which, the petitioners are cited as 'A' party and another community people are cited as 'B' party. He further submitted that the case is pending for more than 1 ½ years and therefore, the case in Crime No. 8 of 2019 has been closed as " Action Dropped" on 10.11.2020.
