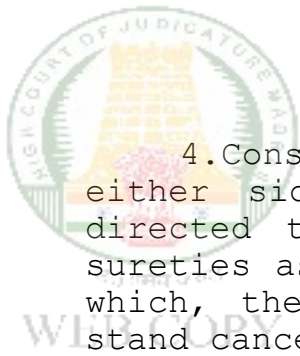

This petition is filed to extend the time limit of the petitioners' surrender and execute sureties in Crl.O.P(MD)No.12368 of 2020, dated 04.11.2020.

2.The learned counsel appearing for the petitioners submitted that as directed by this Court, the petitioners took a Demand Draft in favour of the defacto complainant. But the defacto complainant refused to receive the said Demand Draft. Hence, the petitioners could not able to comply with the conditional order imposed by this Court in Crl.O.P(MD)No.12368 of 2020, dated 04.11.2020. Hence, he seeks to extend the time for a period of four weeks.

3.The learned counsel appearing for the defacto complainant submitted that now the defacto complainant is ready and willing to
