PRAYER IN C.M.P. (MD) .No.10838 of 2017:

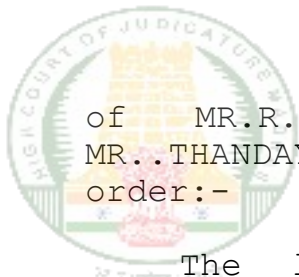
