2. In view of the submission made by the learned Counsel appearing for the petitioner, the Writ Petition is dismissed as withdrawn. No costs.

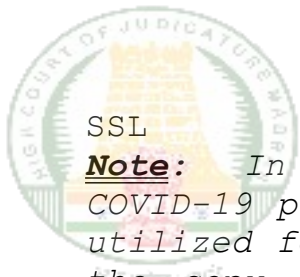
