3.Though the petitioners have given the usual explanation to the delay, the explanation offered by the petitioners in the affidavit filed in support of this petition cannot be ignored. Having regard to the inordinate delay, this Court is inclined to allow this petition on terms. Accordingly, this petition is allowed and the delay is condoned on condition that the petitioners pay a sum of Rs.3,000/- to the credit of "Sidha Clinic" attached to this Bench within a period of two weeks from the date of receipt of a copy of this order, failing which, this petition will be dismissed automatically without any reference to this Court.
