Writ Petition is filed under Article 226 of the Constitution of India praying to issue a Writ of Certiorarified Mandamus, calling for the records of the first respondent relating to the impugned order G.O(2D) No.364 revenue (Ser-2)(1) Department dated 17.8.2012 and quash the same and consequently direct the respondents to sanction full pension to the petitioner within a specified time frame that may be fixed by this Court.
