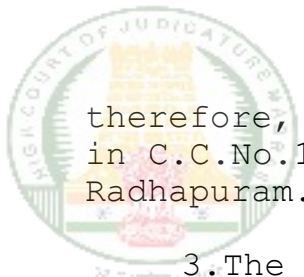

4.In the result, by recording the compromise, the Criminal Original Petition is allowed and charge sheet in C.C.No.1475 of 2020 on the file of the Judicial Magistrate Court, Radhapuram, is quashed. The joint compromise memo shall form part and parcel of this order.
