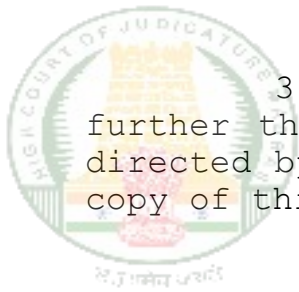
**Prayer in CRL OP(MD).No.12216 of 2019:-**
