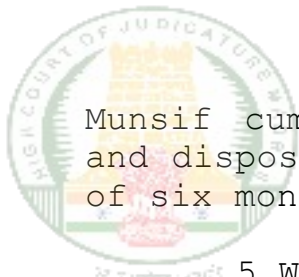
O R D E R

2.The learned counsel for the petitioner would submit that the petitioner is the wife of 1st respondent and they are blessed with two children. According to the petitioner, the 1st respondent has the habit of drinking and attacked the 1st petitioner in Hockey stick. The family members of the 1st respondent are also torturing the petitioner. Therefore, the petitioner has filed D.V.O.P.No.27 of 2018 before the Principal District Munsif cum Judicial Magistrate, Karaikudi in DVC No.27 of 2018 seeking for interim maintenance. The case was posted on 08.01.2021 for enquiry in Cr.M.P. Petition. Hence, the learned counsel would pray for early disposal of the above case.
