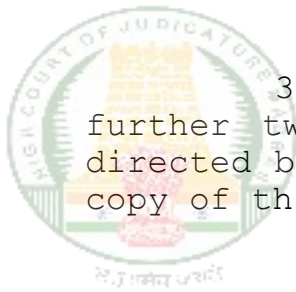
Prayer in CRL OP(MD).NO.8728 of 2020 :-
