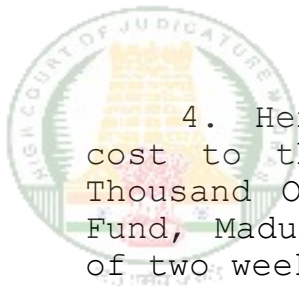
C-33B. For Anticipatory Bail in Crime No. 548/2020 on the file of the respondent police.

ORDER : The Court made the following order :-

The petitioner/A1, who apprehends arrest at the hands of the respondent police for the offences punishable under Section 379 of IPC and Section 21(1) of Mines and Minerals (Development and Regulation) Act, 1957, seeks anticipatory bail.

2.Heard both sides.

3. This Court repeatedly dismissed the anticipatory bail for the petitioner herein on two occasions and the present petition is the third application for anticipatory bail. This petition has been filed without change of circumstances, since it is a case of theft of river sand for four units.

Hence, this Criminal Original Petition is dismissed with cost to the petitioner to pay a sum of Rs.5,000/- (Rupees Five Thousand Only) to the credit of the Hon'ble Chief Justice Relief Fund, Madurai Bench of Madras High Court, Madurai, within a period of two weeks from the date of receipt of a copy of this order.
