ORDER

2.When the matter is taken up for hearing today, the learned Additional Government Pleader appearing for the respondents would submit that by considering the petitioner's representations, final orders have been passed on 18.08.2020 and the same has also been communicated to the petitioner. In this regard, the learned Additional Government Pleader has produced a copy of the proceedings of the 3rd respondent in Na.Ka.No.1952/2020/B dated 18.08.2020 before this Court, wherein, it had been stated that the petitioner has to approach the competent civil Court to workout her remedy, in the



manner known to law. The aforesaid order dated 18.08.2020, is taken out on file and the same shall form part of this order.

3.By recording the said submission made by the learned Additional Government Pleader, this Writ Petition is dismissed as infructuous. No costs. Consequently, connected miscellaneous petition is closed.
