ORDER

This Writ Petition is filed to direct the 1st respondent to measure the land with regard to S.No.244/20 situated at Rajakambiram Road, Rajakambiram Village, Manamadurai Taluk, Sivagangai District.

2.When the matter is taken up for hearing today, the learned counsel appearing for the petitioner would submit that by considering the petitioner's representation dated 23.01.2018, the 1st respondent had rejected the claim of the petitioner and passed final orders on 16.03.2018.

3.In view of the submission made by the learned counsel appearing for the petitioner, the relief sought for by the petitioner has now become infructuous and accordingly, the Writ Petition stands dismissed as infructuous. However, it is open to the petitioner to challenge the



aforesaid rejection order dated 16.03.2018 before the appropriate forum, if he is so advised. No costs.
