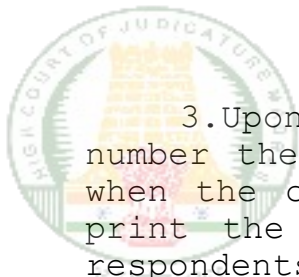
PRAYER IN CMSA (MD) .No.SR43353 of 2016:

To prefer this Memorandum of Civil Miscellaneous Second Appeal against the order dated 19.03.2015 made in C.M.A.No.14 of 2013 on the file of the Sub-Court, Palani, Dindigul District confirming the order dated 12.09.2013 made in District Munsif Court, Palani, Dindigul District.

ORDER : This petition coming on for orders upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of Mr.Arjun Advocate for Mr. T.LAJAPATHI ROY, Advocate for the petitioners and of Mr.H.LAKSHMI SHANKAR, Advocate on behalf of the Respondents the court made the following order:-

This Court finds reasons enough to condone the delay of 354 days in filing the above Civil Miscellaneous Second Appeal, but, on the cost of Rs.4000/- (Rupees Four Thousand only), since there would be considerable inconvenience to the respondents.

2.The learned counsel for the respondents however submitted that the cost of Rs.4000/- may be paid equally to the District Court Advocate Clerks Association at Dindigul and the Advocate Clerks Association attached to Madurai Bench of Madras High Court



3. Upon compliance with the order, the Registry is directed to number the appeal if the papers are otherwise in order and as and when the case is posted for admission the Registry is directed to print the name of Mr.H.Lakshmi Shankar, learned counsel for the respondents.
