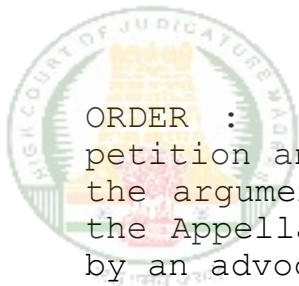
PRAYER IN WA(MD) No.SR4122 of 2018:

Petition filed under Article 226 of the Constitution of India praying for the issuance of a Writ of Mandamus directing the respondents 2 and 4 to regularise the service of the petitioner from the date of his initial appointment as per G.O.Ms.No. 996, P and A reforms (placements) department, dt.22.09.1984 and to give notional promotion to the petitioner and to pay the monetary benefits retrospectively.

2. Though notice has been served and his name appears in the cause-list, there is no representation on behalf of the respondent.

3. This Court has perused Paragraph No.9 of the affidavit filed in support of this petition and the delay appears to be administrative in nature and hence, the delay in filing the above writ appeal can be condoned by putting the petitioners on terms.

In the result, this civil miscellaneous petition is ordered subject to the condition that the petitioners shall jointly pay a sum of Rs.3,000/- (Rupees Three Thousand only) to Additional Registrar General in-charge/Registrar Judicial, for the improvement of the amenities relating to virtual Court proceedings etc., within a period of two weeks from today and the learned Special Government Pleader appearing for the petitioners also undertakes to file a memo through e-mail to the Registry. The Registry on receipt of the said memo, shall number the writ appeal, if the papers are otherwise in order and list it for admission.
