ORDER:-

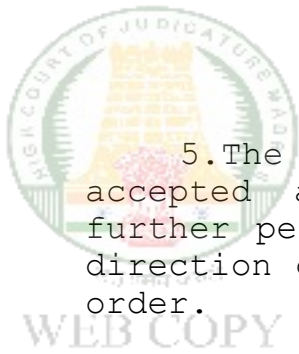

2.This Court, by an order dated 20.01.2020, directed the learned Judicial Magistrate No.II, Kovilpatti, to dispose of the case within a period of four months from the date of receipt of a copy of that order. Thereafter, the Trial Court had sent a letter dated 16.10.2020, for extension of time and the extension of time was granted for a further period of four months.
