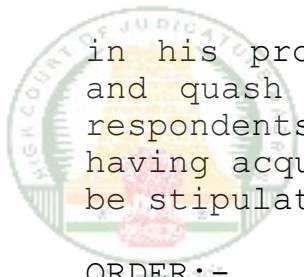
Prayer in WMP(MD). 23326/ 2019 :

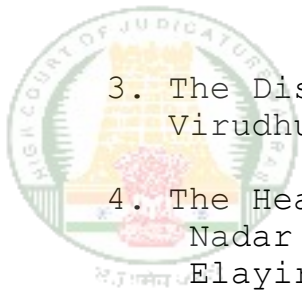
